

# LEP BUSINESS BOARD

SHADOW BOARD MEETING: 22 February 2018

## 1. Confirmation of chair

Cllr Roberts, Deputy Mayor to the Combined Authority and Leader of East Cambs District Council is confirmed by the Cambridgeshire and Peterborough Combined Authority as the Chair of the Shadow Board.

The Shadow Board is an interim governance measure to develop the new LEP Business Board. It will become defunct upon the new LEP Business Board being formed and a private sector Chair being appointed.

It is proposed:

(1) As Cllr Roberts is currently the only member of the Shadow Board, interim nominations are to be immediately sought from the current public sector (x2) and private sector members (x2) within the LEP geography to meet in future as the Shadow Board. See agenda item 3

(2) A letter is sent to Kate Hallett explaining the purpose and function of the Shadow Board, the process and timetable for meeting the requirements of appointing a private sector member Chair to the new LEP Business Board – **Appendix 1**

- Meetings of the Shadow Board are to be held informally until the new LEP Business Board is established and a private sector Chair appointed
- Minutes of the informal meetings will be publicly available and circulated to members of the Combined Authority and member councils of the GCGP LEP
- A decision log will be kept of any proposals by the Shadow Board which are intended to be ratified by the new LEP Business Board at its first meeting

## **6. Appoint Chief Executive**

## **7. Naming new LEP**

The name of the new LEP Business Board should reflect the wider geography of the LEP area. A number of names will be proposed to the Shadow Board at its meeting for consultation with public sector members.

The LEP was initially proposed as a company limited by guarantee. An unincorporated structure is recommended to the Shadow Board for consideration.
