Freedom of Information Request (FOI)

I write with reference to your FOI request received on 6 January 2020 reference CA79. Please find the response provided below.

Question:

In the pre-election period, and soon after announcing a review of the Oxford-Cambridge expressway should the Conservative Party be returned to power, the Rt Hon Grant Shapps, Secretary of State for Transport, was interviewed on 20th November 2019 by Bethan Nimmo of BBC TV South who reported that Mr Shapps, commenting on the one million houses proposals for the expressway, had said that Local Authorities along the route had told him that ‘they can still build those homes and that they don’t need a road blasting through the countryside to do that’.

Yours would have been one of the Authorities contacted in relation to this item since you are included in the area shown on the NIC/5th Studio Report identifying the quantum of the one million houses assigned to each region that you can find in map form on p. 21 of the Report:

Under the Freedom of Information Act (FOIA) 2000 I formally request copies of all communications between Mr Shapps’ Ministry and your Authority that led to Mr Shapps’ statement, specifically:

a) letters, emails or records of telephone conversations made by, or on behalf of, Mr Shapps with your Authority asking if you could still deliver your share of the one million houses even if the expressway is cancelled; and

b) copies of the response of your Authority to this request.

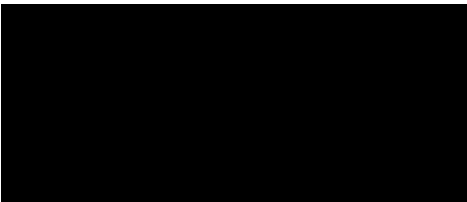
For clarity, the Cambridgeshire and Peterborough Combined Authority is not a local planning authority.
