The costs and benefits of bus franchising in Cambridgeshire and Peterborough will from part of the statutory assessment referred to in the response to b) below.

Question b)

Whether, how and when a system of bus franchising should be implemented in Cambridgeshire and Peterborough.

Answer b)

The Combined Authority is currently investigating the possibility of bus franchising for Cambridgeshire and Peterborough. The procedure which must be followed is set out in the Bus Services Act 2017, which require an assessment of the proposed franchising scheme to be prepared which describes the effects that the proposed scheme is likely to produce and compares making the proposed scheme to one or more other courses of action. Work on this assessment is underway and when it is complete the assessment will be reported to meetings of the Transport & Infrastructure Committee and Combined Authority Board. The detail of the procedure is set out in the 2017 Act, which amends the Transport Act 2000.
