# Freedom of Information Act 2000 – Request for Information Request Reference CA125

With reference to your request for information received on 2 July 2021, reference CA125, please find the response provided below.

# **Question:**

Dear Mr Hill,

I believe you are still Chief Executive of CPCA even if only for a few weeks. I also write to Cllr Alan Sharp who has a role on Overview and Scrutiny Committee. Can you please be kind enough to see that this FOI request gets to the correct officer.

## **Question 1**

What is Mayor Johnson's salary with the CPCA?

### Answer

Holders of public office are not paid salaries. The holder of the office of Mayor is remunerated at a sum established following the convening of an independent remuneration. This last sat in 2019. The Mayor's remuneration is detailed on the reports here:

Is Mayor Johson drawing the full amount? If not, the %age he is drawing.?

## Answer

## **Question 4**

Is Mayor Johnson's role as Mayor part time or full time?

## Answer

The office of Mayor is neither full nor part time. It is not a contract of employment.

Office is held in accordance with the relevant regulation (the Cambridgeshire and Peterborough Combined Authority Order 2017) – that is, beginning with the fourth day after the day of the poll (wherein the individual is elected), and ending on the third day after the poll.

The way in which an individual office holder manages his or her time (whether in relation to external appointments or other matters arising in the course of life) is a matter for the office holder.

Where a question relates to the performance of the functions of the office in relation to particular matters, it may arise in the context of a discussion during a scrutiny question and answer session.
