Request

1. Between 1st January and 31 December 2021, how many electric vehicle charging points (and total connections) were installed by the Cambridgeshire and Peterborough Combined Authority?

2. Were these EV charging points installed for a particular use (e.g. taxis only) or for general public use? Please indicate this in the data provided.

3. For any EV charging point you installed, please indicate if it was a Slow (provide power at 6.00kW or below), Fast (provide power between 6.01kW and 22.00 kW), Rapid (provide power between 22.01kW and 99.99kW) or Ultra-Rapid (provide power at 100.00kW or above) charge point?

4. How many of those charging points (and total connections) were installed using money from the Metro Mayor Capital Investment Fund?

If you or your office should have any additional thoughts or insight on the topic of EVs, we would be interested to hear them.

Response

The number of electric vehicle charging points installed across Cambridgeshire and Peterborough during the course of 2021 is not held by the Cambridgeshire and Peterborough Combined Authority. The Highway Authorities of Cambridgeshire County Council and Peterborough City Council have independently funded EV infrastructure and therefore would hold any information, rather than us.

The development of a carbon neutral region is key to the Cambridgeshire and Peterborough Combined Authority, and this will be highlighted within our emerging Local Transport and Connectivity Plan. In addition, the Authority with Norfolk and Suffolk LEP, are in the process of developing the East Anglian Alternative Fuelled Strategy. This document will be subject to public consultation later this year.
