Thank you for your request for information received on 6 June 2022. The response is given below:

Request

I am writing to make a request under the Freedom of Information Act 2000 regarding Low Traffic Neighbourhoods or "LTNs" in your combined authority. [LTNs sometimes go by different names in different areas, e.g. Active Neighbourhoods, Living Streets, Spaces for People. Here is a definition if helpful: "A low traffic neighbourhood (LTN) is a residential area, bordered by main roads (roads that are often used by buses, lorries and non-local traffic), where "through" motor vehicle traffic is discouraged or removed, while allowing access for pedestrians and cyclists."]

I would be grateful if you would supply me with the following information that relates to any LTN schemes or LTNs by other names in your combined authority.

How much has the authority spent on installing LTNs from the start of 2020 up to and including May 2022? (Please provide a full list of LTNs installed in your local authority, the month and year in which they were installed, and their cost.)

How many LTNs have been altered since their original installation in your authority up to and including May 2022? Please provide the month and year of uninstillation, as well as location. If funds have been spent on alterations, please state how much has been spent.

How many LTNs have since been uninstalled or removed in your authority up to and including May 2022? Please provide the month and year of uninstillation, as well as location. If funds have been spent on uninstillation of LTNs, please state these costs.

How many fines have been issued to people for breach of LTNs in your local authority from January 2020 up to and including May 2022?

How much money does that equate to in total? If you do not hold this specific information I would be grateful if in line with Section 16 of the Act you could provide me advice and assistance as to what information is relevant to my request.

Response

Thank you for your request. Unfortunately, we do not hold the requested information. The Cambridgeshire and Peterborough Combined Authority do not implement any Low Traffic Neighbourhoods (LTNs).

In Cambridgeshire and Peterborough, it is Cambridgeshire County Council and Peterborough City Council that are responsible for LTNs and would therefore hold any relevant information, rather than us.
