Thank you for your request for information received on 8 June 2022. The response is given below:

Request

I am writing to request information regarding fines issued in relation to breaches of Low Traffic Neighbourhood schemes or "LTNs" in your authority. LTN schemes sometimes go by different names in different areas, e.g. Active Neighbourhoods, Living Streets, Spaces for People. Here is a definition if helpful: "A low traffic neighbourhood (LTN) is a residential area, bordered by main roads (roads that are often used by buses, lorries and non-local traffic), where "through" motor vehicle traffic is discouraged or removed, while allowing access for pedestrians and cyclists.

Please could you provide me the following information regarding LTNs under your area: The number of fixed penalty notices (or any other types of fine) issued to people for breaching Low Traffic Neighbourhoods in your authority from May 2020 - Present;

And the total value of fixed penalty notices (or any other types of fine) issued to people for breaching Low Traffic Neighbourhoods in your authority from May 2020 - Present;

The total value of fixed penalty notices (or any other types of fine) issued to people for breaching Low Traffic Neighbourhoods in your authority for the financial year 2021/22. Please could you state how much revenue you expect to collect in the current financial year (or have forecasted in your budget) from fixed penalty notices (or any other type of fine) in relation to LTN breaches.

And how much it has projected or forecasted to collect from LTN breach related PCNs/fines in the next two financial years? If you do not hold this specific information I would be grateful if in line with Section 16 of the Act you could provide me advice and assistance as to what information is relevant to my request regarding the total amount of fees paid to external contractors for their work on LTNs.

Response

Thank you for your request. Unfortunately, we do not hold the requested information. The Cambridgeshire and Peterborough Combined Authority do not implement any Low Traffic Neighbourhoods (LTNs).

In Cambridgeshire and Peterborough, it is Cambridgeshire County Council and Peterborough City Council that are responsible for LTNs and would therefore hold any relevant information, rather than us.
