Thank you for your request for information received on 4 April 2023. The response is given below:

***Request***

*What specifically was the Mayoral Precept spent on e.g. financial breakdown, for 2022-23 and budget forecast spending from funds raised by the Mayoral Precept relating to tax year 2023-24. Did the Mayor ever use public transport to attend activities?*

**Response**

There was no Mayoral Precept for the year 2022-23.

For 2023-24 the forecast income from the mayoral precept is £3.624m, and the entire amount is being used to increase the budget for supported bus services from £3.4m in 2022-23 to £7.0m in 2023-24.

The Mayor's Precept was discussed at the Cambridgeshire and Peterborough Combined Authority Board on 25 January 2023 – item 2.1 Attached is a link to the CA Board meeting [CMIS > Meetings](#)

The Mayor used public transport to attended the following activities in 2022-2023:

- 3 Oct 2022 – Park and Ride Bus – Attended a Roadshow event in Lion Yard, Cambridge.

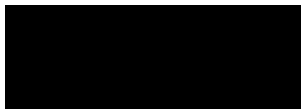
