Request

The amount that was allocated or offered by the Department for Culture, Media and Sport to the authority for 'big screen' events or any other coronation events.

Any information you hold on the cost of any coronation activities in the area.

Response

The Department Culture Media and Sport (DCMS) allocated £45,000 to be distributed by the Cambridgeshire and Peterborough Combined Authority towards Coronation and Eurovision event screenings in our area.

The DCMS grant has been divided equally between 4 organisations at £11,250 each, these organisations are: Cambridge City Council, Peterborough City Council, BID Huntingdon First and Ely Cathedral. The respective organisations can allocate funding across multiple screenings.

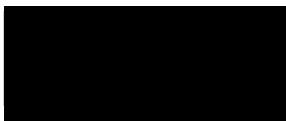
