Request

Under the freedom of information act can you please provide me with the following details. • Who operates your local buses? • Who is the main contact for this? • How many buses are in the overall fleet? • Are Mobile Data SIMs used across the fleet for such items as ticketing, CCTV, payments?

Response

The Combined Authority does not own a bus fleet and contracts out the operation of bus services where these are not deemed to be commercially viable. 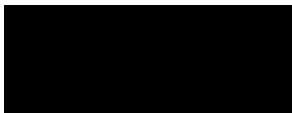

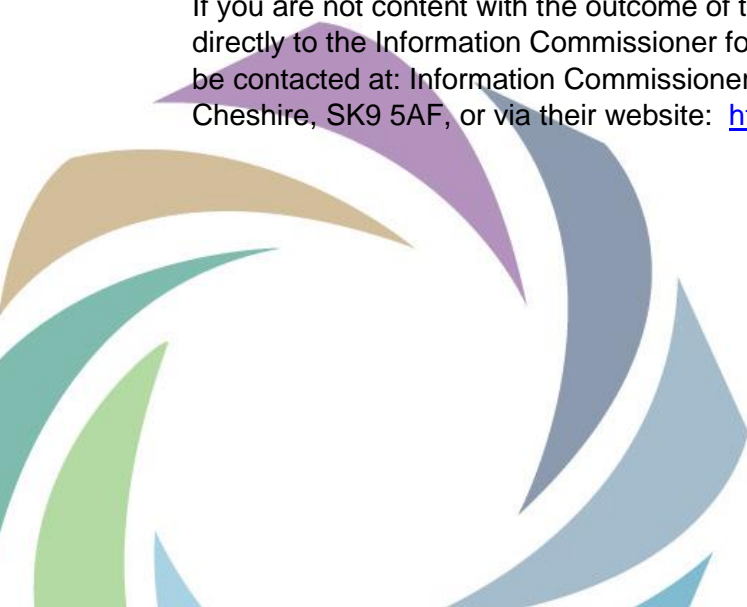
