Thank you for your request for information received on 01 December 2023. The response is given below:

***Request***

*The FOI request revolves around the complaint and investigation into Mayor Dr. Nik Johnson and his behaviour and breach of Code of Conduct as widely reported and is public knowledge. His public apology contains redacted content which fails to identify what he has done. As a public servant in his position, we have a right to know. I wish to know in full what the complaints involve I e bullying or harassment or general undesirable behaviour . I DO NOT want personal details of the complainants only what he was investigated for and found to be guilty of. This is not a National Security breach and is not privvy, as far as I am aware to any government, local or otherwise protection or privilege. I would like an unredacted (except for complainant's) response fully detailing the content of the investigation into his behaviour.*
