I write with reference to your request received on 24 September 2018 and your modification email which was received on 27 September, reference CA28

Please find the response provided below.

**Question:** Having received guidance from the communications team at the CA, I would like to modify my request please.

1. Can I instead ask how many staff (both permanent and interims) and consultants have received, or will receive, £80,000 or more this year?
2. Can I have the names of the individuals and details of their roles/the organisations they represent?
3. And can I also find out how much each of the people received and, if they are not in their role permanently, how many days they have worked for their money?
4. And I would like to find out how many interims and consultants have been employed by the combined authority in total this year? Can this please be broken into separate categories for interims and consultants.

**Answer:**

1. There are 13 members of staff (both permanent and interims) and consultants who have or will receive £80,000 or more this year.

2. We can confirm that we hold this information. However, save where indicated otherwise, this information is exempt from disclosure under section 40 (personal information) of the Freedom of Information Act 2000 (FOIA). This is because the information constitutes personal data as defined in the General Data Protection Regulation (GDPR) and disclosing it would breach the principles of fair and lawful processing set out in the GDPR.

In relation to the roles/organisation they represent, the information is as follows:

This is because the information constitutes personal data as defined in the General Data Protection Regulation (GDPR) and disclosing it would breach the principles of fair and lawful processing set out in the GDPR.

- 1 Interim directly engaged by Cambridgeshire and Peterborough Combined Authority
- 1 interim seconded from his organisation.
- 8 Interims engaged via an agency
- 8 Consultants indirectly engaged and provided by their employer/organisation for specific projects and deliverables.

Information in relation to the sums paid is published on the Authority's website and therefore the exemption under Section 21 applies.

The remainder of the information that you requested is exempt under section(s) 40 (Personal Information – names of individuals) and 43 (Commercial Interests – information which would lead to disclosure of an hourly rate which would affect the commercial interests of the individual) of the Freedom of Information Act 2000 and is therefore withheld.
