Please find the response provided below.

Questions:

- 1. The number of officers who earn more than £75,000 per annum for the combined authority.**
- 2. What their salaries are specifically.**
- 3. What are their departments, positions and names.**

Answer:

1. There are 8 officers posts of the Council that have salaries above £75k.
- 2 and 3. The posts, departments and salary band details are shown below. We will not be providing the names of the individuals as the information constitutes personal data.

Section 40(2) of the Freedom of Information Act 2000 provides that:

“(2) Any information to which a request for information relates is also exempt information if—

- (a) it constitutes personal data which do not fall within subsection (1), and
 - (b) either the first or the second condition below is satisfied.
- (3) The first condition is—

(a) in a case where the information falls within any of paragraphs (a) to (d) of the definition of “data” in section 1(1) of the [1998 c. 29.] Data Protection Act 1998, that the disclosure of the information to a member of the public otherwise than under this Act would contravene—

(i) any of the data protection principles, or...”

In this case we believe that disclosure of the information would result in a breach of the first data protection principle, as stated in the Data Protection Act 1998 (the DPA):

Personal data shall be processed fairly and lawfully and, in particular, shall not be processed unless—

(a) at least one of the conditions in Schedule 2 is met.

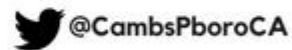
Generally, the ICO will not undertake a review or make a decision on a request until the internal review process has been completed.
