Please find the response provided below.

Q1 - how is the Cambridgeshire and Peterborough Combined Authority funded?

Cambridge and Peterborough Combined Authority is currently funded by devolved funds from Government. It receives £8m revenue and £12m capital gainshare funding each year which is to meet the running costs of the organisation and any project costs identified in the devolution deal. The CPCA Board will be considering its draft budget for 2019/20 and MTFP to March 2023 at its meeting on 28th November 2018. Those papers will be available on the CPCA website from 21st November 2018.

Q2 - I need to understand why a severance payment was made to Martin Whiteley when he left due to his own resignation.

This information is exempt as it is already in the public domain.
