Re: Freedom of Information request ref CA421

Thank you for your request for information which was received on 6th May 2025.

Request

I would like to request the following data from the Cambridgeshire and Peterborough Combined Authority, covering the past three academic years:

- 2021/2022
- 2022/2023
- 2023/2024

Specifically, I am requesting a comparison of measurable economic outcomes for learners participating in the following Adult Skills Fund (ASF) / Adult Education Budget (AEB) provision types:

- Procured ASF/AEB provision
- Grant funded ASF/AEB provision
- Grant funded Community Learning/Tailored Learning (ASF/AEB) provision

For each of these three types, I am requesting data on the proportion or number of learners who progressed to the following outcomes:

- Onward learning or further study (e.g., further qualifications or training)
- Employment (including new job attainment or transition into employment)
- Progression in employment (e.g., promotion or wage growth)

I believe all of the requested data is available through ILR returns pertaining to the above funding sources.

If possible, I would appreciate if the data could be broken down by year and by provision type, with clear definitions used for each outcome category.

If any part of this request is unclear or would require refinement to meet cost/time limits under the FOI Act, I would be happy to assist in narrowing the scope.

Response: Please find below the requested data – six tables, two for each academic year split by funding model. In each academic year there is one for Community Tailored Learning and one for AEB (inc FCFJ). The data has been taken from the final return of each of the academic years requested.
