Please find the response provided below.

## Jobs and cost

<ol> <li>How many jobs have been created on the enterprise zone/s since its creation in 2012? Please include a breakdown of jobs created for each financial year and only include enterprise zones which were set up in 2012</li> </ol>
Answer: To date there have been 585 jobs created on the enterprise zone since 1 <sup>st</sup> April 2012.
Breakdown by financial year:
2012/13 – 86
2013/14 – 17
2014/15 – 82
2015/16 – 20
2016/17 – 245
2017/18 - 135

2) How many companies were there on your enterprise zone/s as of the 1<sup>st</sup> of April for each financial year that the enterprise zone/s have been running since 2012? (please only include enterprise zones which were set up in 2012)

Answer: There are 14 businesses currently operating on the enterprise zone. Breakdown by financial year:

2012/13 - 4 2013/14 - 6 2014/15 - 11 2015/16 - 9 2016/17 - 11

2017/18 - 14

3) How much private sector investment (£ millions) have you received each financial year since your zone/s creation in 2012? (please only include enterprise zones which were set up in 2012)

Answer: 2013/14 - 6 2014/15 - 54 2015/16 - 10 2016/17 - 15 2017/18 - 27
