

With reference to your FOI request CA59 dated 5 March 2019, please find the response below:

Question:

- How many days were lost to sickness in 2017/2018?
- Please can you provide; the total number of days lost, the average days lost per employee and the amount lost as percentage of available hours / time?
- How many days were lost to sickness linked to mental health, including but not limited to: stress, depression and anxiety in 2017/18?
- Please can you provide; the total number of days lost, the average days lost per employee and the amount lost as percentage of available hours / time?
- Does your organisation use the Bradford Factor and if what score do you use as the initial trigger for an intervention? For example; once an employee has a Bradford Factor score of 100 or more, formal disciplinary action commences?
- Please can you advise whether you use the Bradford Factor? Y/N
- If you do, please can you advise at what score the initial intervention is triggered?
- If you do, please can you advise what the initial intervention is?

Answer:

We do not keep information in the format that you have requested. Individual details of sickness absence by members of staff are retained but as these are personal to the officer they would not be appropriate for release.

I confirm that the Combined Authority does not use the Bradford Factor.
