Question 1 - Total staff in the combined authority

Answer: 63 permanent staff.

Question 2 - Number of policy staff

Answer: 10 permanent staff.

Question 3 - Number of delivery staff

Answer: 17 permanent staff. This includes finance staff, HR staff and PAs.

Question 4 - Number of finance staff

Answer: 6 permanent staff.

Question 5 - Number of legal staff

Answer: 4 permanent staff.

Question 8 - Total annual spend on capital and revenue projects to benefit the economy.

Answer:

Below is a summary of expenditure by the CPCA on projects which benefit the local economy. Where a breakdown of capital and revenue was reported this has been given.

The figures for 2017-18 and 2018-19 are actual expenditure figures, those for 2019-20 are based on forecast expenditure at the end of March 2020, and those for 2020-21 are from the draft budget approved for consultation by the CPCA Board in November 2019.

It should be noted that, due to a change in internal accounting practices, the figures in 2020-21 include staffing where the project has a ringfenced funding source, in prior years these project costs were reported net of staffing costs.
