**FREEDOM OF INFORMATION REQUEST – CA84
RE: HUNTINGDON THIRD RIVER CROSSING**

I write with reference to your email to the Highways Team at Cambridgeshire County Council which was passed to the Cambridgeshire and Peterborough Combined Authority and received on 29 April 2020, reference CA84. Please find the response provided below.

Question

How can this enormous waste of public funds be acceptable on a project of unproven and questionable value where little attention has been given either to the case or the alternative options?

Answer

I wish to assure you that Cambridgeshire and Peterborough Combined Authority is not committed to a particular solution. At the Transport and Infrastructure Committee on 09 January 2020 a decision was taken to incorporate the Huntingdon Third River Crossing into the A141 Huntingdon Capacity Study and St Ives Area Transport Study to consider the wider growth aspirations in the area. Included within this was the need for a high-level Environmental Desktop Study, with the intention of producing an Options Assessment Report for the wider area. It is essential that we consider all options when undertaking transport studies where central government funding would be required for final delivery, this is to demonstrate all possible solutions have been considered before a final investment decision.

The study work is ongoing, outcomes will be published in the coming months. The outcomes of the report will be presented at the Cambridgeshire and Peterborough Combined Authority Transport and Infrastructure Committee, the date of this



presentation is yet to be finalised but the date will be published on the Combined Authority Forward Plan. There will be an opportunity for the public to attend and make representations which is welcomed. A decision will be made at this meeting on the next steps based on all the evidence.

Question

Why have the public had so little opportunity so far to comment or object to these proposals? This is undemocratic and unacceptable. This must be discussed out in the open now, and not when the bulldozers move in.

Answer

There have been opportunities where the public are able to and have made representation on matters related to the Third River Crossing at the Cambridgeshire and Peterborough Combined Authority Board Meetings and these are welcomed. To date there has been representation at the following Board meetings:

Again, this will be presented at the Committee meetings where public representation can be made.

Question

How exactly does such a proposed development support the Government’s stated strategy for nature conservation and the environment proposed in the 25-year Environment Plan, or the proposals contained in the Government’s Environment Bill pledging to reduce carbon emissions to zero by 2050?



Answer

We are aware of the Government strategy for nature conversation and this is consistent with the overall vision of the Local Transport Plan which seeks to protect and enhance the environment through sustainable growth.

As stated above, an Environmental Desktop Study has been included as part of the wider area Option Assessment Report.

Question

Finally, where are the Cambridgeshire County Council or the Huntingdonshire District Council policies that should be protecting our precious and diminishing landscape assets?

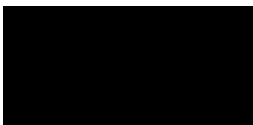
