This support role was being contracted through EELGA Talent Bank until 31 March 2020 but Officers have gone out and run a procurement process to appoint a provider to deliver the EU funding support role for the CPCA until 31 March 2021.</i></p> <p><i>The ESIF Support role will be reporting to the Strategic Funds Manager.</i></p>
