The winning bids after scoring determined to be:</i></p> <p><i>ICT/Digital – Cambridge Wireless</i></p> <p><i>Advanced Materials & Manufacturing (AMM) – Hethel Innovation Ltd</i></p> <p><i>Life Sciences/Healthcare – no bid received scoring highly enough to take forward</i></p>

Appoint in-house development of strategies – potentially not enough capability in-house to do this option – the exception here is Agritech/Agri-food which is being developed in-house by Agritech Specialist. 4.
