Decision taken	To authorise the grant agreement for £1m funding contribution between the CPCA and Essex County Council for the M11 Junction 8 project
Authorisation ( <i>delete as appropriate</i> )	This decision has been taken in response to the resolution of the CPCA Board on the 28th November 2018 to:  'release the £1m Growth Deal funding to Essex County Council, to support the delivery of the range of improvements outlined within this paper for the M11 Junction 8'.

<p>Background Information</p>	<p>As part of its Growth Deal bid, the Greater Cambridgeshire Greater Peterborough (GCGP) LEP secured £1 million of funding from central government to support Essex County Council's (ECC) planned improvements to Junction 8 of the M11.</p> <p>The CPCA took over the undertakings of the LEP from April 2018 and established the Business Board as the area's LEP.</p> <p>On November 26<sup>th</sup>, the Business Board received the business case for the M11 Junction 8 and recommended the funding be released to ECC, the CPCA board ratified this on November 28<sup>th</sup>.</p> <p>In the time since, ECC and CPCA have reached agreement on the terms of the funding agreement that would release the funding.</p>																																				
<p>Alternative options considered.</p>	<p><i>List alternative options considered and rejected and the reasons for rejection. Do not leave this section blank or put 'None'. There is always an alternative even if it is to do nothing.</i></p> <p>A do-nothing option, meaning a refusal to release the funding, would mean the CPCA revoking a decision made at board level, as well as damaging relations with a neighbouring Local Authority that is reliant upon the funding for delivery of a locally important scheme.</p>
